ROH § 8-7.5, 5 Year Dedication



If the Parcel is currently within a five-year residential use dedication, do not fill out and submit this form. The five-year residential use dedication will automatically renew for another five-year period unless a written request to cancel is submitted to the director on or before September 1 of the 5th year from the start date of each dedication period. If a petitioner is unclear if the Parcel is already dedicated for residential use, the petitioner may review the Residential Use List at <https://www.realpropertyhonolulu.com/dedications/property-dedicated-for-residential-use/>.

1. Enter the Parcel ID (Tax Map Key). Separate petitions must be filed for each TMK. This information can be found on your Notice of Assessment or by contacting the Real Property Assessment Division ("RPAD").
2. Enter the petitioner's name (primary contact person), telephone number, and email address.
3. Enter the site address of the property.

5. Enter the type of land zoning that the property is located on. Is the property fee simple or leasehold? If leasehold, enter the expiration date of lease.

  - b. Apartment building, number of apartment building(s) and total number of apartment units.
  - c. Condominium unit and project name.
  - d. Condominium parking unit which is used in conjunction with a residential unit within the same project.
  - e. Condominium storage unit which is used in conjunction with a residential unit within the same project.
7. Enter the type of use. Check applicable boxes.

If hand delivered, the completed petition form must be received by RPAD no later than 4:30 p.m. on September 1<sup>st</sup> preceding the tax year in which the dedication will become effective, at one of the addresses listed below. If the petition is mailed, it must be postmarked by the U.S. Postal Service, by September 1<sup>st</sup>. If a receipt of the petition is requested, enclose a self-addressed stamped envelope. The petition cannot be filed by facsimile transmission or via email.
